A charitable bequest is one of the easiest and most flexible ways that you can leave a gift to Moody that will make a lasting impact.

Benefits of a bequest

- Receive an estate tax charitable deduction

How a bequest works

A bequest is one of the easiest gifts to make. With the help of an attorney, you can include language in your will or trust specifying a gift to be made to family, friends or Moody as part of your estate plan, or you can make a bequest using a beneficiary designation to:

Here are some of the ways to leave a bequest to Moody Bible Institute

- Include a bequest to Moody in your will or revocable trust
- Designate Moody as a full, partial or contingent beneficiary of your retirement account (IRA, 401(k), 403(b) or pension)
- Remember Moody as beneficiary of other financial accounts (custody accounts, bank accounts, CDs, etc.)
- Name Moody as a beneficiary of your life insurance policy

A bequest may be made in several ways

- Percentage bequest—make a gift of a percentage of your estate
- Specific bequest—make a gift of a specific dollar amount or a specific asset
- Residual bequest—make a gift from the balance or residue of your estate

Sample wording for your attorney to review

You can use language in your will to direct Moody to use your bequest for General Ministry, Education Ministry, Broadcasting Ministry, or Aviation Ministry.
